It is, therefore, incumbent on the Secretary to comprehend the following abstract from their rules :

The certificates to the intending participants should be issued duly signed in Ink and should bear the Seal/Stamp of the Congress/Academy. They will not be accepted for the grant of concession if they bear the facsimile signatures. A copy of the form of certificate is attached.

The procedure for availing concession by an individual member will be as outlined below :

You are required to submit the certificate to the Authorised Officer of the Railway concerned, namely, the Chief Commercial Superintendent, the Divisional Commercial Supdt., Etc., who will issue you the Concession Order, on presentation of which only the Station Master will allow concession to you.

I shall, therefore, request you to kindly get the certificate cyclostyled and despatch to the individual members along with the information bulletin for the conference, keeping in view that each individual cyclostyled certificate form should be signed in ink by the secretary and it should be complemented by the stamp of the Association.

Should you need any further clarification, I shall be pleased to help you. Please advertise widely this item through the column of the journal, so that the members of the Association are aware of the new contingency.
