

RAIL TRAVEL CONCESSION FOR ATTENDING NATIONAL CONFERENCE

It is for the information of the members of the Indian Association of Dermatologists Venereologists and Leprologists that the name of our association is included on the standard list of bodies eligible for travel concession in respect of Annual National Conference appearing in IRCA Coaching Tariff No. 23, Part-I (Vol. II). Accordingly, the delegates to the 18th National Conference of IADVL to be held at Jaipur in January 1990 will be eligible to the rail concession on the following conditions :

1. The concession will be available for the second class return tickets only, on payment of one and a half ($1\frac{1}{2}$) single second class mail fares.
2. The concession is allowed only to the persons attending the conference and not their families.
3. The concession will be available to the persons with total earnings/emoluments of not more than Rs. 2000/- (Rupees two thousand) per month. A certificate to this effect will have

to be supplied by the member along with the request.

Members desirous of availing the concession are requested to apply to the Honorary General Secretary, at the address given below, for application forms and proforma of certificate along with a self addressed Re. 1.00 stamped envelop. The concession form will be sent to the concerned members after receiving the prescribed application forms from them duly filled and signed (in duplicate).

The following details must accompany the request for the concession form : (1) Name in capital letters, (2) Address, (3) Membership code No, (4) Name of the branch (if direct member, please mention), and (5) Name of the railway station from which the journey to and from Jaipur is to be performed.
